- The club is governed by a Board of Directors composed of volunteers.

- Members have access to a calendar of rides. Group rides are led by a certified Ride Leader.
- Vero Cycling works closely with Bike Walk Indian River County (BWIRC) on state and local advocacy issues with a focus on making our community safer and more accessible for people who ride bicycles. Club members also work with BWIRC rehabbing bikes and distributing them to adults and children who need basic transportation to work and school.
